The costs to defend the case were covered by iCare NSW and TAFE NSW did not see the invoices associated with this. The cost of the initial investigation was \$105,000.

**The CHAIR:** Are you in a position to say that every TAFE has an onsite counsellor on some days of the week?

**JULIE TICKLE:** No, I would not be in a position to say that. We would need to take that on notice and provide more information. What I can say is that every TAFE campus and every student at TAFE has access to counselling. Whether it is in person, via the phone or using Teams, which is the portal we use, every student has access to counselling.

**The CHAIR:** I appreciate that, and that's good, but the nature of trauma from sexual assault is that people sometimes need to see somebody in person, or they're really not willing to take that step. There are also people who are worried about security concerns, and there all sorts of other reasons. Can you tell me how many TAFE campuses don't have any onsite counselling?

**JULIE TICKLE:** We would need to take that on notice and come back.

#### **ANSWER**

All current and prospective TAFE NSW students at all locations and online have access to professional services, either face to face on-site, through online meeting platforms or via telephone to the TAFE NSW Counsellor and Career Development statewide network. While some campuses may not have a permanent on-site Counsellor, TAFE NSW Counsellors travel to various locations as needed.

In February 2024, TAFE NSW introduced a Same Day Response Team providing direct assistance to students and staff with an urgent Counselling support need. This service works in collaboration with TAFE NSW business-as-usual counselling support.

Additionally, TAFE NSW Counselling and Career Development services facilitate connections to external professional services to ensure comprehensive support for all students.

Is that going to look at the quality of the courses? What was that about? Then Manila and Beijing, there's one to each of those in the information that we've been given through GIPAA.

**STEPHEN BRADY:** I think I have to take on notice what the purpose for each individual one was.

#### **ANSWER**

**Abu Dhabi** (May 2023) - visit foreign government bodies and meet with clients in person; meet with potential funding organisations to develop further training opportunities for both offshore and study tours; and pursue continuous business with existing and new partners.

**Shanghai** (Trip 1 June 2023) - (Shanghai listed on travel request as it is a transit city to Ningbo where the partner college is located). Represent TAFE NSW at the graduation ceremony at Ningbo City College (NCC); maintain and enhance new and existing relationships with the Chinese partners (Shijiazhuang Vocational College of Technology and Information (SVCTI) and explore opportunities for expansion; visit partner college campuses and meet with senior management at the local colleges; meet with Chinese provincial government authorities, Austrade and Investment NSW for networking purposes and to explore further expansion into the region; investigate feasibility for future business development and collaboration of other programs; compliance checks and high-level discussion on delivery issues related to Director of Studies was a key action for the trip.

**Shanghai** (Trip 2 June 2024) - as above however this visit was to maintain and enhance existing relationships with the Chinese partners Shanghai AXGZ Education Training Center Co. Ltd, Austrade and Global Link China. Compliance and delivery discussions also occurred.

**Manila** (November 2023) - meeting with key education agent partners (IDP Education, AMS Global, AMS Bridge Blue, KOKOS, Global Study Partners, Expert Education, Progress Study, AECC Global); group workshop/training session for education to ensure compliance with ESOS requirements; meet with Australian government agencies (Austrade Manila).

**Beijing** (May 2024) - attend exhibition/seminar for international students; visit education agents to train new agent counsellors to ensure agent compliance with ESOS requirements.

The Hon. SARAH MITCHELL: It's page 4-31 of Budget Paper No. 03. Up the top of the table, under "Major Works", it says "New Works", "Capital Projects", "Various". Over the course of the next four years it's an \$88 million estimated total cost, and this year's allocation is \$22.6 million. I'm curious as to what falls into that "Capital Projects" \$22.6 million for this financial year.

**STEPHEN BRADY**: The \$88 million consists of a number of elements. One is there are minor works projects, which consists of a range of small projects, really. I'd have to come back to you with a breakdown of what that is.

### **ANSWER**

Page 4-31 of Budget Paper No.3 shows a total allocation of \$88.7 million in FY24/25 for minor works. It also shows \$88.4 million over the FY24/25 to FY27/28 period for new major works which consists of \$65.8 million for the Manufacturing Centres of Excellence project, and \$22.6 million for the Northern Rivers Reconstruction project.

For the current financial year, \$22.6 million is allocated, consisting of \$20.6 million for Manufacturing Centres of Excellence, and \$2.0 million for the Northern Rivers Reconstruction.

The Northern Rivers Construction allocation for this financial year will predominantly be used for design of replacement facilities across the cluster of Northern Rivers campuses including Lismore, Wollongbar, Casino and Ballina.

**The CHAIR:** The way that I understand e-tendering to work is that there's a tender put out for a specific scope of work. If there was to be an expansion of that scope, then you would consider that as a separate thing. It would be an additional amount that would go under an additional contract. There's no explanation as to why this has just increased.

**MARGOT McNEILL:** I'll have to come back to the Committee with that information on notice for the specifics about that contract.

.....

The CHAIR: Right. In which case, there should have been another contract process undertaken or a registering on eTendering of an additional amount. There's no explanation in this. There's another one here to a Strawberry Solutions company. This is a 3½-year contract from 1 September 2022 to 24 February 2026. This one has gone from \$460,000 to \$2.2 million. That's over four times the increase in value. Both of these were registered with eTendering on 9 May. How can that be such an increase under the same contract?

**MARGOT McNEILL**: Again, I'll have to come back with the details on notice. But it will be because we work with those external partners on the material development. **The CHAIR:** Minister, does it worry you, the lack of transparency over these sorts of contracts?

**Mr STEVE WHAN:** In terms of not being able to provide that information, we'll do our best to provide that information for you.

The CHAIR: Are you able to provide me perhaps on notice with the 31 providers that you have creating these products and how much each of their contracts are?

**Mr STEVE WHAN:** Along the lines of the EY and Strawberry Solutions ones that we had before?

**STEPHEN BRADY:** Right, okay.

Mr STEVE WHAN: Yes.

### **ANSWER**

TAFE NSW utilises two approved procurement panels for product development and support, the Third Party Learning Products Panel and the Partnership Supply Panel. These panels operate under "consumption-based call-off contracts", which means that work is commissioned as needed from providers on the panel, with the contract value increasing as work is allocated and completed over time. Actual spend is disclosed through quarterly reporting in eTendering.

This approach aligns with the NSW Government procurement policies.

The Third Party Learning Products Panel is made up of 32 suppliers.

**The CHAIR:** Mr Dizdar, in relation to the 30 ongoing roles being cut potentially from the HSC strategy team, how many are temporary roles? I understand there are the permanent ones, but how many temporary contractors are there in that team?

#### **ANSWER**

I am advised by the Minister for Education and Early Learning that:

The NSW Government is committed to the highest quality education in our public schools. Work is underway by the Department of Education to ensure that we simplify the support that we give to schools. As part of this, the department is addressing the duplication - in some cases the triplication - of roles within the Department among non-school based teaching service positions (NSBTs).

Most of the NSBTs are teachers who came from public schools, and they have jobs in our classrooms to return to where their expertise is needed.

Our government is doing everything it can to address the teacher shortage including ensuring more of our expert teachers are back in front of classrooms where they are most needed. We know this is where they can make the most difference to educational outcomes for our students.

Under the proposal, a net 245 NSBT positions out of a total 1,296 would be impacted, of which 142 are currently vacant.

The department says it is likely to conclude these changes by early 2025.

### **ANSWER**

The Department of Education's Education and Skills Reform division announced their divisional changes on 5 September 2024. This followed a period of consultation with staff which occurred between 8 to 22 August 2024. Feedback from staff led to changes made to the future state design.

There are reductions in Public Service Senior Executive positions, government sector employees and non-school based teaching staff positions.

There are 76 government sector employee positions being deleted, of these 27 ongoing roles and 17 temporary roles were filled. The remaining roles were vacant. Twenty-seven new government sector employee roles will be created including 20 ongoing roles and seven temporary roles.

There are five non-school based teaching staff positions being deleted, four of these positions are vacant and were never filled and relate to a program that was discontinued. One of these positions is filled with a temporary employee.

Public Service Senior Executive Positions will reduce by four.

The submission called for funding certainty for providers to improve access and support delivery of holistic wrap-around services. It also called for more transparency around how universities use funding loadings to support underrepresented students.

VTAS payments include:

- a travel allowance of 33 cents per km (home address to college),
- an accommodation allowance of \$56 per night (block release training only).

VTAS payments are uncapped, however a student must meet the eligibility requirements to receive the travel and/or accommodation allowance. The amount an apprentice or new entrant trainee receives through VTAS differs depending on the distance they travel and their need for accommodation.

Apprentices and new entrant trainees may be eligible to claim the accommodation allowance for the night before and/or after their block training, providing they can outline the reason why this accommodation is necessary.

Apprentices and new entrant trainees in cross-border communities may be eligible for financial assistance from the Vocational Training Assistance Scheme (VTAS).

To be eligible for VTAS payments a student must meet the following requirements:

- Be registered in NSW as an apprentice or new entrant trainee under the Apprenticeship and Traineeship Act, 2001,
- their place of employment is in NSW,
- have to travel more than 120kms (round trip) for off-the-job training.

Apprentices and new entrant trainees of cross-border communities travelling from one area to another must meet the above eligibility criteria to access VTAS payments. Most notably, they must travel more than 120kms (round trip) for off-the-job training. Students travelling between the towns of Albury and Wodonga would not meet this requirement and would therefore be ineligible for VTAS payments.
