I have read with much interest many of the 400 odd submissions to your committee.

One of the most obvious problems is how to combat the arguments relating to " Noise " of Amplified Sound created at night by Live Bands and DJ,s etc operating inside and OUTSIDE venues around Sydney. We believe these arguments should not be ongoing as Technology is now available to solve between 95% and 98% of these problems. The fact is that because the Technology is a commercial product Local Government at all levels fail to support it even though many senior individuals within Government are aware of it,s proven success around the World and here in Australia and NZ. If it was a Life Saving device they would be jumping all over it !!

Totally different scenario in America where Governments are desperate to solve this major issue without letting Politics get in the road of simple proven solutions. When you click on the first link below you will see a live recording of OUTDOOR tests done in front of the City Of Austin (Live Band Capital of The World) Council Offices . The City sponsored these tests as they had run out of ideas and realised that Acoustic Engineers could not solve their problems without turning down the volume of the sound OR modify the building to such an extent that the economics were never a reality. In Australia we are also staggered that many Acoustic Engineers fail to suggest this technology as a possible solution when every venue who has installed it to solve a " Noise Issue " has had outstanding success. In this part of the World 200 systems have been installed.

One of your submissions references the " Night Time Mayor " of Amsterdam. It is my understanding that this Mayor has visited the USA and has been updated on the OUTSTANDING success of the trials carried out in Austin Texas. It is no coincidence that a very large installation of this technology is about to take place in his part of the World.
