## **Dear Director**

I refer to the NSW Legislative Council's Public Accountability Committee - Inquiry into the impact of the WestConnex Project.

On 18 December 2014, the then Auditor-General published a performance audit report on WestConnex: Assurance to the Government. This report assessed how effectively project assurance processes were applied to WestConnex to provide independent assurance to Government and thus improve project development and delivery. The report made six recommendations, which were largely accepted by the agencies.

The Public Accounts Committee released a report 4/56 – March 2017, Examination of Auditor-General's Performance Audit Reports, December 2014 – June 2015. The WestConnex report was one of those examined and the Committee determined that the agencies concerned were fully implementing the Auditor-General's recommendations.

On 15 December 2017, I published a financial audit volume titled Report on Transport 2017. This report discussed the budget for the WestConnex project. The relevant detail from this report is:

Although TfNSW expect this project to be completed on schedule in mid-2023, there were two budget revisions since 2014. The project budget was increased to \$15.4 billion in May 2015 and a further increase of \$1.4 billion in October 2015 due to changes to the scope of work. Transport advises the changes include an extension of stage three to Anzac Bridge, Victoria Road and the future connection of the Western Harbour Tunnel and Beaches Link.
